The *Albany Law Review* is soliciting short article submissions for publication in its annual symposium issue. Selected articles will be published in the first issue of volume seventy-four, scheduled for January 2011.

Beginning in 2011, the *Law Review* will reserve half of the first issue for the publication of articles and lectures on a specific topic of contemporary importance to the legal community. Generally held in the fall or late winter, the symposium features presentations by some of our nation's leading legal scholars and policy leaders. This year's symposium will focus on the legal, political, environmental, and social effects of the BP oil spill. The symposium will examine the numerous legal actions that are sure to ensue, the current regulatory framework and what changes are likely to occur, as well as discuss the roles of the EPA and Coast Guard in performing such an enormous cleanup operation. Short articles by legal scholars, industry professionals, and law or graduate students are now being sought on related subject matter.

Format and Length

Short articles are between 10 and 20 pages in length. Articles need only be lightly footnoted. All articles submitted should be of publishable quality and in substantially finished form.
